ORDER GRANTING DISBURSING AGENT'S AMENDED EX PARTE MOTION TO APPROVE PAYMENT OF DISTRIBUTION AMOUNTS ASSOCIATED WITH CERTAIN OUT-OF-STATE UNIT-WEEK(S) INTERESTS TO CLERK OF BANKRUPTCY COURT UNCLAIMED FUND REGISTRY IN LIEU OF THE STATE OF FLORIDA UNCLAIMED FUNDS

THIS CAUSE came before the Court upon Disbursing Agent's Amended Ex Parte

Motion to Approve Payment Distribution Amounts Associated with Certain Out-of-State Unit
Week(s) Interests to Clerk of the Bankruptcy Court Unclaimed Funds Registry in Lieu if the

the State of Florida Unclaimed Funds (the "Motion") [ECF # 196]. The Court having reviewed the Motion and record in the case, and finding that considering the circumstances detailed in the Motion, and despite the Disbursing Agents extensive efforts to issue distributions to the Unit-Week(s) Interests were not successful, the Court finds that no party in intertest will be prejudiced by the distribution of all such amounts associated with certain out-of-state unit-week interests to the Clerk of the Bankruptcy Court in lieu of the State of Florida Unclaimed Funds, as previously provided for by the Plan [ECF # 53] as Confirmed [ECF # 97] and previously authorized by the Disbursement Orders [ECF # 175, 184 and 190] (as defined in the Motion). Accordingly, it is --

ORDERED as follows:

- 1. The Motion is **GRANTED**.
- 2. All distribution amounts associated solely with the out-of-state unit-week(s) interest listed on the Unclaimed Funds List, attached as Exhibit A1 to this Order shall be disbursed to the Clerk of the Bankruptcy Court in lieu of the State of Florida Unclaimed Funds.
- 3. The Disbursing Agent is authorized to send all such disbursements to the Clerk of the Bankruptcy Court and the Clerk of the Bankruptcy Court is directed to receive such deposits.
- 4. Out-of-state unit-week(s) interest listed on the Unclaimed Funds List or their heirs may, on petition to the Court and upon full proof of right thereto, obtain an order directing payment to them, using the forms attached hereto as Exhibit A2.
- 5. To the extent CM/ECF shall require the Disbursing Agent to enter such unit-week interests' owners or beneficial owners as "creditors" into the unclaimed funds

registry, such designation shall not alter their designation as unit-week(s) interest owners in this case rather than "creditors".

6. The Disbursing Agent is direct to serve by mail and/or e-mail a copy of this Order and post on the website maintained at https://www.eisingerlaw.com/palmbeachresort-bankruptcy/, a copy of this order in a prominent location.
