## FINAL REPORT AND MOTION FOR ENTRY OF FINAL DECREE

Pursuant to Local Rule 3022-1(A), the undersigned files this Final Report and Motion for Final Decree and represents:

- 1. The plan of liquidation in this case was confirmed on November 10, 2021 [ECF # 97]. On March 3, 2022, the Debtor substantially consummated its Chapter 11 Small Business Subchapter V Plan Filed by Debtor Palm Beach Resort and Beach Club Condominium Association, Inc. [ECF # 53] (the "Plan"), by closing and consummating the sale transaction of all 29 Units as contemplated by the Plan and approved by the Court [ECF # 111], and transferring the funds to the disbursing agent, (as provided in the Confirmation Order). The plan provided for a 100% dividend to unsecured creditors on the effective date, and provided for the distribution of all assets of the association and of the unit-week owners' interests pursuant to the terms of the plan.
- 2. All assets have been distributed and all matters to be completed upon and following the sale of Units.
- 3. There are no pending adversary proceedings or contested matters which would affect the substantial consummation of this case.
- 4. All administrative claims and expenses have been paid in full, or appropriate arrangements have been made for the full payment thereof. A summary of fees and expenses is as follows:
